

Announcement of Kasetsart University

Regarding the determination of service fees and fines of Krissana International Dormitory

In order for the collection of service fees and fines of Krissana International Dormitory to proceed smoothly, the university therefore canceled the old announcement and complied with the new announcement as follows:

- 1. Eligibility of Residents; -
 - 1.1 International students
 - 1.2 Graduate students of Kasetsart University
 - 1.3 Authorized third parties
- 2. Monthly stay rates are as follows (maximum of 2 persons):
 - Dormitory fee 6,000 THB per room per month
 - Advance room charge 6,000 THB per room
 - Damage guarantee deposit 6,000 THB per room
 - Key card 100 THB per person

Utility fees

- Electricity cost 5 THB per unit
- Water supply cost 16 THB per unit
- 3. Daily stay rates are as follows:
 - 3.1 International students or Kasetsart University students
 - 3.1.1 Room rate 600 THB per day including the utility fees
- 3.1.2 In case of staying more than 10 days but not more than 1 month, the room rate must be paid monthly 6,000 THB excluding the utility fees. However, the residents must inform the staff of the number of the residents and the number of days of stay in advance.
- 3.1.3 Daily residents may stay no more than 2 per room. If more than 2 people but not more than 4 people per room, additional room charge of 300 baht per person per day. However, the residents must inform the staff of the number of the residents and the number of days of stay in advance.
- 3.2 Authorized third parties
 - 3.2.1 Room rate 800 THB per day including utility fees.

3.2.2 Daily residents may stay no more than 2 per room. If more than 2 people but not more than 4 people per room, additional room charge of 400 baht per person per day. However, the residents must inform the staff of the number of the residents and the number of days of stay in advance.

- 4. The residents must pay the dormitory fee as defined by the University within the specified time.
- 5. The residents of the same room must jointly pay the actual utility fees and within the specified time.
- 6. The residents must pay damage guarantee deposit at the specified rate and will be refunded when the resident submits a request to move out of the dormitory and checks for overdue or absence of damaged or missing materials in the room.
- 7. The residents who do not pay dormitory or utility bills as scheduled will have to pay the fines as specified by the university.
- 8. Other Fines
- 8.1 In the event that the residents pay for the dormitory late, the fine of 50 THB must be charged per day per room.
- 8.2 In the event that the residents pay for the utility fees late, the fine of 30 THB must be charged per day per room.
- 8.3 In the event that the residents borrow a spare key to open the room, the fine of 100 THB must be charged per time.
- 8.4 In the event that the residents lose his/her key card, he/she can request for a new one at the office, the fine of 100 THB must be charged per card.
- 9. The residents must not allow incoming of a visitor to the dormitory without the building warden's consent; otherwise the residents must pay the fine of 1,000 THB per day and the visitor must pay the fine of 1,000 THB per day.
- 10. In the event that any supplies and durable goods in the room are broken from a misuse or a misapplication of their condition, the resident must pay the fine as defined below; -

10.1 Bed	Damage rate	4,500 THB
10.2 Mattress	Damage rate	3,500 THB
10.3 Desk	Damage rate	3,500 THB
10.4 Chair	Damage rate	1,900 THB

10.5 Electrical appliance in the room, the damage rate is charged according to the condition.
